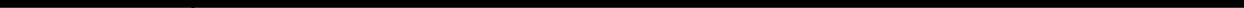

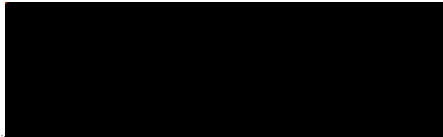
1. *Staphylococcus aureus* (ATCC 12228) was grown in Tryptone Soy Broth (TSB) (Difco) supplemented with 0.5% yeast extract (Difco) and 0.5% glucose (Difco) at 37°C. Cells were harvested at mid-log phase (OD₆₀₀ = 0.5) and washed with phosphate buffered saline (PBS) (pH 7.4) containing 0.1% bovine serum albumin (BSA) (Sigma) and 0.1% penicillin-streptomycin (Sigma). Cells were then resuspended in PBS containing 0.1% BSA and 0.1% penicillin-streptomycin.

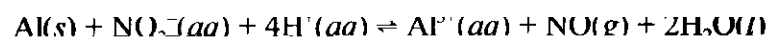
